

Instructions for the China Online Visa Application (COVA) for Student Participants In the Jiangsu-DKU-Duke Summer 2024 Cultural & Experiential Learning Visit (Aug 2-10)

Step 1) Ensure your passport will not expire before March 2025

Step 2) Make sure you have two completely blank, consecutively numbered “Visa” pages in your passport booklet (last few pages do not count as they are for ‘endorsements’)

Step 3) If your passport expires as in Step 1 or lacks pages as in Step 2, you may need to renew your passport first and via expedited processing

Step 4) Complete the Qualtrics survey in order to secure your DKU invitation and Duke support letters

Step 5) Proceed to the online visa application once you have passport, letters and photo



Once you complete your COVA, it will be electronically submitted to this Embassy or Consulate and you will either make an appointment to self-submit or send originals to Duke's approved expediting agency, [Travel Document Express](#)





Select "North America" as region where you will apply

Select City of Consulate/Embassy you will apply through (NC residents select "Washington D.C." and use your Duke address in app)

PLEASE NOTE: if you select the wrong city, it will invalidate your entire application. You will have to start anew under the right Embassy/Consulate city.



Top selections are to “Start an Application” or “Retrieve an Application,” if you are just beginning leave in default and click blue button at bottom; if you are returning to a SAVED application, click on “Retrieve an Application” and enter your COVA number, passport number and the letters/numbers in the CAPTCHA field.

- (*) This website is supported by Google Chrome, Windows Internet Explorer 8.0 or higher, Mozilla Firefox 3.6 or higher, Safari 5.0 or higher and Opera 13.0 or higher.
- (*) The completed COVA application will be in PDF format, which requires [Acrobat Reader](#) to view.
- (I) When completing the COVA, you must use the “Back” or “Save and Next” buttons at the bottom of each page instead of the back/forward buttons on your browser.
- (II) Please answer each question accurately. Questions marked (*) are mandatory. You have to answer all the mandatory questions on the page before proceeding to the next step. If some of these questions do not apply to you, please tick “Not Applicable” to proceed.
- (III) Any inquiries on completing the COVA will be addressed by clicking the “Help” button on the upper right corner of the section.
- (IV) By clicking the “Save” button found on the bottom of each page what you have completed up to that point will be saved for 30 days. To return to a partially completed application, please click the “Retrieve an Application” button on the homepage and enter your application ID and Passport/Travel Document Number.
- (V) **Please be sure that all information is complete and accurate before you click the “Submit” button. Once the application is submitted, you cannot make any changes.**
- (VI) Completing the 9-page COVA form online and clicking the “Submit” button does not necessarily mean your visa application has been delivered to the Chinese embassy/consulate. A printed and signed COVA form together with the other necessary documents (is still required when applying for a Chinese visa.
- (VII) A visa appointment may be required by the Chinese embassy/consulate ([click here to schedule an appointment](#)). Your application ID will be needed to book an appointment.
- (VIII) Please fill in the form in [Chinese](#) or [English](#).

Once your passport is returned, here is an example of how to read your CHINA ENTRY VISA

A China Entry Visa is a full-page sticker applied into your Passport Booklet on a page designated for "Visas."

Note: you must have two blank, consecutively numbered "Visa" pages; it states "Visas" on the page; the last 4-pages in U.S. passports are for endorsements, NOT visas and should not be counted as such.

An "Academic Visitor" visa is a Category "F" visa

China Visas become valid on the day of issue and expire at a point – typically 3-months from the issuance date – in the future. The traveler can enter China at any point between these two dates for at least two visits.

Note: if your travel dates shift from what was originally noted in the COVA, that is fine. Any entry after the issuance date and before the 'enter before' date is allowed.

Typically "F" visas are single- or dual-entry, allow for up to a 30-day stay in the country and are valid for entering for up to 3-months.
